Atlantic House Defined Returns Fund

Monthly Factsheet - May 2024



Fund Overview

The fund aims to deliver an annualised net return of 7% to 8% over the medium to long-term in anything but the bleakest of market conditions. It will do so via an actively managed exposure to a diversified portfolio of defined return investments linked to global equity indices. It invests primarily in UK Government Bonds to provide the return of capital to investors over time, alongside a portfolio of global, liquid derivatives that generate the return on capital. Due to the nature of the investments, the fund's behaviour in different market scenarios should be more predictable and the returns more probable.


Monthly Commentary

May was a good month for equity markets, with the UK large cap market continuing its recent form, rising 2.1%. Headline inflation is now down to 2.3%, whilst core inflation failed to come down to its estimated levels, which temporarily halted the equity market's gain. In the US, despite indications from the FED that interest rates may not be coming down too soon, the US large cap market recovered its April fall by rising 4.8% this month, thanks to strong earnings reports from some big companies. The EU also reversed April's fall with the large cap market there rising 2.1%. The sensitivity ('delta') of the fund to equity markets is still relatively low at 25%, so it makes sense that the fund was up 0.85% for the month. As markets have been generally rising, the fund is seeing consistent maturities of its autocall positions each month. In May there were four maturities, three on their first-year anniversary and one on its third year. The terms for the new autocalls that are replacing these continue to be relatively good. The funds managers continue to focus on achieving as much downside protection whilst obtaining the required annual coupon to meet the fund's return target. As the maturities come and new trades are put on, the delta naturally increases slightly, resulting in the fund participating more in the movement of equity markets.



Forward Looking Scenario Analysis and Intrinsic Value

Estimated Fund Move or 'Intrinsic Value'

The intrinsic value is the aggregate terminal value of the Fund considering estimated fees over the relevant period. The table above shows that, for example, if an investor bought the Fund today and none of the markets on which the investments were based moved between now and when the investments mature, the Fund would increase by 5.62%, a terminal value of GBP 2.1464 (based on current NAV of GBP 2.0321). What this does not tell us is the yield that is represented by these intrinsic values.

Average Time to Holdings' Maturity or Duration

The table above also shows the weighted average time to maturity of the investments held within the Fund. Currently this is 0.84 years

because, at current market levels, most of the current investments are likely to mature within 1 year. This number gives the investor an idea of how long it will take for them to earn the Equivalent Annualised Return.

Equivalent Annualised Return or Intrinsic Value (Annualised)

The table also shows the current expected return of the Fund considering estimated fees for certain movements in the underlying indices. For example, if markets do not move, we would expect the Fund to yield 6.73% given its current make-up. You can also see that we would expect a positive return if the market falls 20% and then stays at that level until all investments mature.


